Scheme requirements

A reminder to scheme Operators of the requirements in regard to taking representative samples for testing. Clause 11.3 of PAS 100 states that 'Each sample shall be representative of the compost batch from which it is obtained'. Under the Compost Certification Scheme, only single representative samples can be sent for analysis to an appointed laboratory and the approach of splitting representative samples for specific test(s) is not considered acceptable for certification purposes.

Subsampling of a representative sample for the various analytical tests is carried out by laboratory personnel following standard operating procedures. Please refer to section 6 ('Splitting samples for pathogen testing') of the <u>CCS Position on Technical Requirements</u> for more information.

Further, REAL would like to offer some clarification in regard to Clause 13.1.1 f) of the current version of the Scheme Rules that came into effect on the 1st January 2019.

REAL receive enquiries from individuals and organisations seeking information on which compost sites accept certified compostable liners and or/certified compostable packaging. As a producer, should you accept these materials, Clause 13.1.1 f) asks whether you consent to your company details being shared so as the individuals and organisations in search of this information can locate it via our website.

'Company details' refers to the publicly available information shared on the 'Producers' page of our website. Individuals can then more easily find sites to take this material for composting.
